Subject: - Grant of Dearness Relief to State Government Pensioners/Family Pensioners-Revised rate effective from 01/01/2012.

In pursuance to the Ministry of Personnel, Public Grievances & Pensions, Govt. of India's OM No P. 42/13/2012-P&PW(G) dated 4<sup>th</sup> April, 2012 on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to decide that the Dearness Relief (DR) payable to the State Government Pensioners/Family Pensioners shall be enhanced from the existing rate of 58% to 65% with effect from 01-01-2012. The arrear for the period from the month of January 2012 to June 2012 be drawn and paid in cash during the month of July 2012 and thereafter may be paid every month in cash as usual.

All other terms and conditions as enunciated in Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioners Welfare, Govt. of India's aforesaid OM shall remain unchanged.

OFFICE MEMORANDUM.

Subject: Payment of Dearness Allowance - Revised rates with effective from 01.01.2012

In pursuance to the Ministry of Finance, Govt. of India's OM No. 1(1)/2012-E-I Dated 3rd April 2012 on the subject mentioned above, the Government of Arunachal Pradesh has decided that the Dearness Allowance (DA) payable to State Government Employees be enhanced from the existing rate of 58% to 65% with effect from 01.01.2012 to be paid from salary bill of July 2012. The arrear DA for 6 (six) months would be paid in the following manner:

- (i) The 3 (three) months arrear DA from the month of January 2012 to March 2012 to be paid in cash during the month of July 2012.
- (ii) The arrear DA for 3 (three) months from April 2012 to June 2012 is drawn & deposited in GPF accounts during the month of January 2013.

2. The expenditure on account of this additional Dearness Allowance will be met from existing Budget provisions under Plan/N.Plan of the Department concerned in the C.Financial year 2012-2013.

3. The revised rates of Dearness Allowance will be applicable to regular Government Employees only and will not apply to private/Non-Government institutions receiving grants-in-aids from the State Government.
